Chief will be gone August 22-26 for Lenox training. CIT (Critical Incident Training) training is coming up first week of September, it is free training. Hopefully will get officers in with Kettering Network training. Need to rotate officers for training.

Couple of invoices for repairs of police vehicles from wear and tear. Before Yates funeral Officer McHenry got cars cleaned and waxed at a very reasonable price, thanks to them and McHenry.

A lot of the tickets that are written go to the Municipal Court which have no funds for the Village. Possibility to get some funds if the Ohio Revised Code is adopted as our own ordinance, is it possible to have both and need to check into it.
