REPORTS:

Mrs. Thome reported the village will have streets swept at the end of April or the beginning of May. Rebert Pike will be closed at Enon-Xenia from April 11 thru April 18 from 8-6 p.m. for intersection work. Residents in the area have been contacted and a one call alert has been issued as well. The Main St water tower interior and exterior has been primed with work completed by the end of April. The village has been contacted for another Eagle Scout project with interest of redoing the Galloway Park sign. The current Eagle Scout project has progressed and concrete pouring is scheduled this weekend for the sidewalk connecting the back of the government center to the Heritage building. Mrs. Thome went over highlights of the Annual Report of Operations for the village year 2018. April 27th is scheduled for replacing smoke alarm batteries, (Diana Wood) contact. Chief Wilcox Reports:

Other option to be considered is to have an increase of \$5 per license plate issued. The issues of having only a rear license plate are being issued as the law enforcement agencies are addressing their concerns of the one plate change effective December 21, 2021. The increase in revenue of gas tax will help with revenue in the street department as the village will need to start grinding and new overlay of streets.
