**COMMUNICATIONS:**

**Mayor:** The Mayor thanked the Department Heads and Staff for watching the expenses for the 2020 calendar year. The 2020 expense percentage of each department are the following: General 85%, Street 92%, Police Levy 76%, Water 83% (no expenses on cleaning the tower in 2020). The expense percentage of all the funds together was 82%. The Village received 105% of the 2020 Revenue that was budgeted. (\$80,000 more than what was expected)

**Administrative:** Administrator Siferd updated Council on the Video/Sound System that was installed by Perigon. Andrew and Jason from Perigon, were recommended by Mark Wells (Website Company). The new microphones has a button that allows Council to put their microphone on mute if they were going to cough etc. The Administrator has an i-pad that allows him to start and stop the video. Once the Administrator gets comfortable with the new system, he will be able to have additional camera angles and be able to zoom in to the individual speaking. Mr. Whitacre thanked Perigon. This will be great for our community. Mr. Whitacre inquired about the comments during the live

stream. Those have been turned off due to no one from the Village being able to monitor or respond back to the comments/questions. The Mayor thanked Andrew and Jason.

Key Fobs – The Administrator informed Council that the key fobs are working good and that Council has a key fob that will get them into the front, back and security door.

Cardinal Tower – The Administrator announced that the inside painting is complete. There was a test that showed two areas that needed attention but it was decided that it was best for the company to come back in Spring to fix it. A new contract was completed and signed. The water tank will be filled next week.

Mr. Whitacre **made a motion** to accept the Mayor’s Court Report as presented. Seconded by Mrs. Sweet.


