- Hoping for a closing right after April 5 on the property we are purchasing with the Township
- We received American Rescue Plan Funding to be used for different criteria; one aspect of that can be for premium pay for employees that their work involves regular interaction with the public or other coworkers.

At this time clerical and the Admin side full time employees for 2020 receive an amount of 750.00 for 2021 an amount of 750.00. For part time in the Admin group, 750.00 total. On the water and street side for the employees such as labor and supervisor who had usual and customary duties for both of these years, they would also be receiving the Admin side for full time of 750.00 and 750.00 but additionally if they were with us in both years and their duties required them to be out in the public and dealing with people on a face to face manner such as our water and street department that they would receive an additional 750.00 in total. So they would receive the 750.00 for 2020, 750.00 for 2021, and if their job duties entailed being actively interaction with the public then they would receive 750.00 full time.

For our Police Department who I would consider at close contact interaction with the general public what I would like to propose is for our full time officers for 2020, 1500.00, for 2021 1500.00. If we had any part time in 2020, part timers would receive 500.00 for 2020 and 500.00 for 2021.

I am open to other suggestions but that would be my motion at this point.
