Larry Schaffer, Director of Environmental Health, Clark County gave a presentation of the West Nile cases found in Clark County. The program to test the mosquitos for West Nile Virus is funded by the EPA.

COMMUNICATIONS: Mayor Howard reported Joe Smaldon thanked staff for the nice job done on the property on Green St. Resident Glen Baker reviewed an Enon safety project; the project mirrored the plan of the village for walking on Enon-Xenia for sidewalks.

REPORTS:

Mr. Siferd reported Aspen Energy could potentially save the village \$12,500 in electric cost. Aspen Energy's plan is a 36 month plan whereas Palmer Energy would give no numbers for savings until an agreement was signed. THE OPWC grant for the culvert on Bob White Dr. grant cost \$169,000 with the village's portion of \$30,000. The grinding and repaving projects cost are grant \$139,100 and village \$30,000. The fire hydrants are being power washed and then painted. A local resident on Rebert Pike donated a shed 12x16; the shed was placed by well #3; the cost to move the shed was \$400. No permits were required by Clark County. Keep Wayne Hensley's father in your prayers. The well footer on #3 well looks good and the crew will start laying brick and redo the floor. The Neptune water meter meeting will be on Thursday; Badger meeting will be next Tuesday. Mrs. Thome made note of the blood drive will be held on August 15th 3-6 p.m. Mrs. Thome requested council for a motion authorizing the Clerk of Court to enter into an agreement with the Bridge Payment for credit card payment services.
