The by-pass valve in the water tank had to be replaced at the Main St. tank; Enon Relief and the Enon garage will be affected by the water repair. The village will be obtaining estimates on a computer (laptop) for the water reading and software for the radio read meters. The cost is approx... \$12,000.00. Citizen of the year is coming up and the ceremony is planned at the Church of God west Enon for May 5<sup>th</sup>.

Phase II of Main St. is being reviewed with a STVG block grant (smart light with a battery backup is the best chance for the grant.) the project will also include 6 to 12 street lights and a crossing light at the intersection. Choice One will be assisting to write the grant. The grant usually takes 2-3 years to get approved. Wayne Hensley passed his water Operator 1 license. Clark County Engineers applied for TIP money to improve Mud Run bridge, sidewalks to Indian Valley School, new storm sewer, and resurface the road from Dayton Springfield on out to new school. The project is estimated at \$2,700,000.00. Clark County has money for the design of this project. Blood Drive will be held February 11<sup>th</sup> from 3-6 p.m.
