REPORTS:

Village Administrator

Mr. Siferd presented facts related to the disrepair of a key VOE vehicle, which is retrofitted with a snowplow during the winter months. To ensure the VOE meets citizen needs and maintains safer, plowed roads - leasing a new truck is imperative. Utilizing a State of Ohio vehicle program, Mr. Siferd indicated the VOE could enter a 5-year lease for a 2020 Ford F-550 with a snowplow package; costing approximately \$80,000. He requested the Council approve a motion

Chief of Police

Chief Holler advised Council and citizens the VOE will participate in the National Prescription Drug Take Back Day. This event will occur on October 26, 2019/10:00 AM-2:00 PM, in front of the Enon Government Center. The Chief noted National Prescription Drug Take Back Day aims to provide a safe, convenient, and responsible means of disposing of prescription drugs, while also educating the general public about the potential for abuse of medications.

The Chief also advised us the City of Fairborn notified the Enon Police Department they no longer had the resources to perform maintenance on our law enforcement vehicles. The Chief is looking into other options right now; but more than likely, any new maintenance/repair will be performed by the private sector, or local automotive repair companies.

In closing, the Chief mentioned the Trick-or-Treat event hosted at Enon Primary was well attended and appeared to be a success.

OLD BUSINESS:

Mayor Howard, Mr. Siferd, and Mr. Rose updated attending Council and citizens on the latest developments related to our existing water meter equipment/software challenges, and a proposed way ahead to resolve the associated issues. After significant research and due diligence, they determined Montgomery County already developed the requirements and specifications for all essential equipment/software; and these requisites mirror the VOE's needs. Additionally, Montgomery County already solicited bids and determined the 'best value' supplier was Neptune Equipment Company. Using an Ohio Revised Code provision authorizing reciprocity, Montgomery County will allow the VOE to participate in their Contract/Pricing Agreement with Neptune. This saves the Village significant time in the requirements definition and acquisition process, thus permitting us to purchase state-of-the-art endpoints and meter interface units (MIUs) which work seamlessly with prior generations of equipment; as well as transmit meter reading data *without* reprogramming. Capitalizing on this opportunity ensures the Village's ability to preserve the public peace, health, safety, and welfare in this declared emergency.
