COMMUNICATIONS:

Communication was received form the Clark County Combined Health District in regards of placing a mosquito trap or two near the water tower on Cardinal Drive in Enon. The mosquito trapping program will run throughout the summer and the traps will be checked daily.

REPORTS:

Mr. Rose reported three properties on Nightingale were having issues with drainage; the front pipe was jet cleaned and the drainage is clear. Staging for construction of the Main Street upgrade for ADA compliance sidewalks and additional lighting along the main road will begin after Memorial Day; work to be completed sometime this summer. Rose reported the water meter readings will be done on the last week of the month. The radio read for water readings has cut the process down from four employees reading for five days to one to two employees

reading for half a day. Mayor Howard, Mr. Rose and Mrs. Thome attended a EPA Cyber Security training session; topic of protecting records and electronic files from ransom ware.

Chief Wilcox Reports:

Chief reminded council the Pizza Festival will be held June 9th from 3-9 p.m. A new program was introduced by the Chief "AARP Fraud Fighters"; how to protect yourself and loved ones from scams and fraudulent activities. This program will be an hour long session; adults are welcome so RSVP as seating is limited. Program date is June 19th at 6 p.m. with a picnic dinner to follow the session. Officer Stratton completed 40 hours of training for bicycle class. The 4th of July Parade permit has been issued.
