### REPORTS:

Mr. Siferd reported the flushing of the fire hydrants went very well. The painting of the fire hydrants is 50% complete. The patching of the crosswalk for Apple Butter and some other streets in the village will be in mid-October. Paving at the end of Green St. will be next year

with a cost estimate of \$6800. The fire inspector was out and the village had only one violation; the emergency lights didn't light due to batteries failing. Batteries have been ordered. Mrs. Thome is working on refining a few things on the website. Water Dept. crew will be attending training along with Admin. Siferd in Covington this week from 8-1p.m. This training class is with the Rural Water Association and has 4 credit hrs. available to earned.

Chief Wilcox requested for the night off. Mayor Howard reported the search warrant on Hunter Rd. was tied to a homicide in Yellow Springs and not concentrated on a resident inside the apartment.

#### OLD BUSINESS:

Mayor Howard reported the hand held device for water meter reading has been sent back to Badger and a loaner has been given to the village to use for reading the water meters. Badger has issues and the best move forward is to put a bid out to price. The bid will give input to the village for cost and will with a formal bidding process the specs for the village will be explained and the best option for the village will be reviewed. Mayor requested that Shelby Engle be contacted for advice on this project with the water meters. Code enforcement in the village will be enforced; boats, campers and some carnival equipment on property. Councilman Babcock reported the new website is set to launch around October 1<sup>st</sup>. The website is now a .gov vs. .com site. The old site will redirect public to the new .gov site for a short time.
