REPORTS:

Mr. Siferd reported all three zoning appeal cases were approved by the zoning board; two were setbacks and one height variance request. The recent snow removal went well by staff. The water department is ahead of the preparation of paperwork for the sanitary survey for the EPA. A letter will be sent out to the owner of the property storing amusement park equipment. The new server has been completed and the software is now located in the back storage closet. Online water payments are expected to be available the end of November. Mayor's Court Report will be presented at the next meeting. Mrs. Sweet added the Christmas tree service will be held on December 7th with the arrival of Santa and Mrs. Claus to follow.

Chief Wilcox Reports:

Chief Holler thanked a residence for the brownies. Chief briefed council on the arrest with a homicide suspect in Enon; all agencies (including BCI and Greene County) worked together and kept the department informed of updates of this arrest. The speed trailer needs batteries charged and then will be operational.
